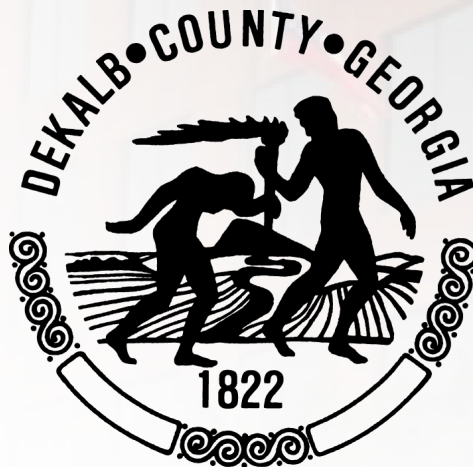

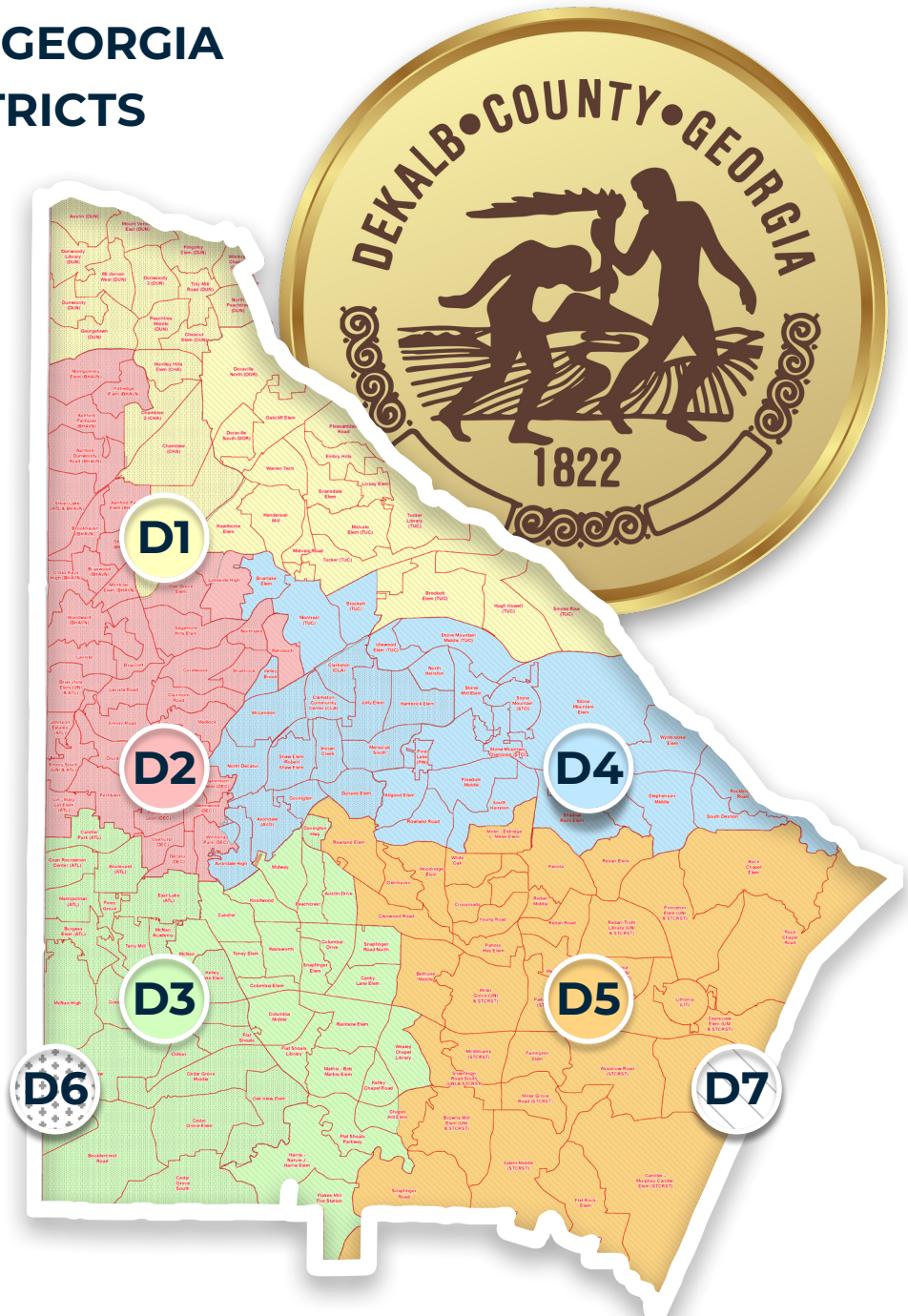
DISTRICT 4 INFORMATION

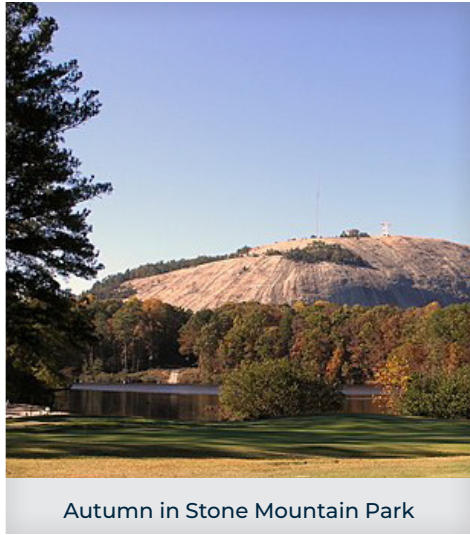

The DeKalb County Board of Commissioners consists of seven members: five district commissioners representing approximately one-fifth of the county per member, and two "super district" commissioners representing roughly one half of the county apiece. The super districts overlap with regular districts, providing multiple representatives for every area of the county.

Central DeKalb’s beautiful parks and lively community centers host events year-round to unite our beloved communities.

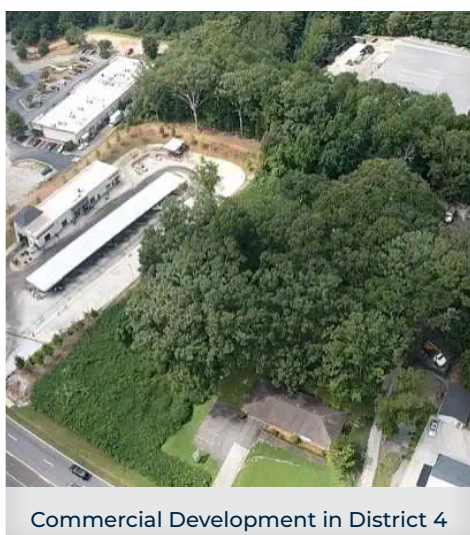

STEVE BRADSHAW

Born in Charlotte, North Carolina to a military family – his father spent his career in the US Navy. He was also born into a religious family, as both of his grandfathers were pastors. Upon his father’s retirement from military service in 1977, the family moved to Savannah, Georgia, where Steve spent his formative years, graduating from Armstrong State College with a Bachelor of Arts in 1986. He joined the US Army as a Second Lieutenant and was trained as a tank commander. Over a seven-year military career, Steve served in various line and staff positions of increased responsibility, including service in the Middle East during the First Persian Gulf War. **The military taught him sacrifice, discipline, and devotion to duty.** He left the Army as a Captain in 1993 to pursue opportunities in the private sector.

Steve held several operations, management, and business development positions with companies including John Harland Company, Briggs Equipment, Spherion, and Delta Global Staffing – a subsidiary of Delta Air Lines. **The private sector taught him flexibility and the importance of checking the numbers.**

Steve earned his Master’s Degree in 1998 in Public Administration at Georgia State University and was invited to be an Adjunct Professor in the Andrew Young School of Policy Studies, teaching graduate and undergraduate-level courses. **Being at the helm of the classroom taught him patience.**



Steve has been engaged in the community for many years, serving on boards of directors for organizations including The Giving Tree (an adoption resource agency), The Clarkston Community Center, and Pride Rings in Stone Mountain (PRISM). He also served on the State Water and Wastewater certification board, and Governor Roy Barnes appointed his position.

Steve has been married to his wife, Diane, for 37 years, and they have called DeKalb County home for 31 years. He enjoys reading, playing golf, and watching his favorite professional football team, the Pittsburgh Steelers.

Steve was elected to the DeKalb County Board of Commissioners in 2016 with 89% of the vote. He was re-elected to the seat in November 2020 without opposition and was elected unanimously by his peers as the Presiding Officer of the Board of Commissioners in 2020 and 2021.

Steve performs the duties of his office with diligence, integrity, and honor as he serves the citizens of District 4 and DeKalb County.

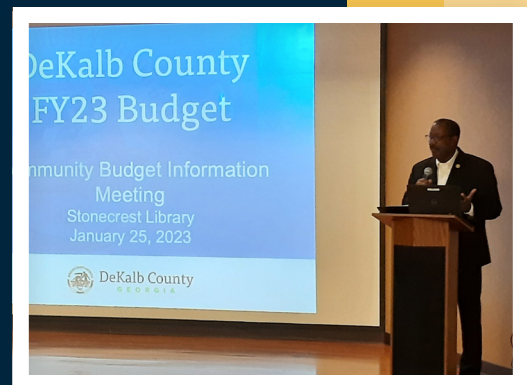
FISCAL RESPONSIBILITY

Director of the Office of Management and Budget, T.J. Siegler, was on hand to present information and answer questions. Our first hybrid meeting in Stonecrest allowed constituents to engage in the budget process.

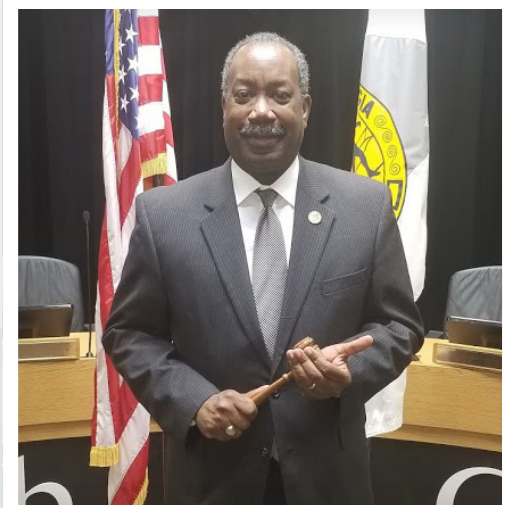

WHAT IS THE GENERAL FUND?


In unincorporated and incorporated areas of DeKalb county, the general fund pays for county-wide services such as the courts, Sheriff's Office, Tax Commissioner, Chief Executive Officer, Board of Commissioners and administrative departments like the Law Department and Human Resources. In short, the general fund supports county operations.

Sections 36-91-110 through 36-110-119, which would provide a framework for the County to consider partnerships with private entities for the development of a wide range of project for public use, commonly known as "P3s".

DEKALB 2023 BUDGET INCLUDED \$100,000 FOR THE DEKALB CHAMBER OF COMMERCE

MEMORIAL DRIVE

Revitalizing Memorial Drive in DeKalb County is crucial for fostering economic growth, enhancing community engagement, and creating a vibrant urban landscape. The effort involves improving infrastructure, beautifying public spaces, and supporting local businesses, serving as a catalyst for community pride. Additionally, the project can preserve the area's historical and cultural heritage, making it a collective investment in the well-being and prosperity of the entire community. The revitalization of Memorial Drive remains the top priority of my second term in office.

MEMORIAL DRIVE COMMUNITY REBRANDING INITIATIVE

Commissioner Bradshaw, in partnership with Houser Walker Architecture, the DeKalb County Department of Planning and Sustainability, and the Department of Community Development, hosted a public meeting to present finalists for both the logo and branding efforts.

Originating from the Memorial Drive Revitalization Corridor Plan, The Memorial Drive Community Rebranding Initiative began in 2019 and was adopted by the Board of Commissioners in 2020. The study recommended rebranding the corridor to help change the public perception of the area and give the area an identity and sense of place.

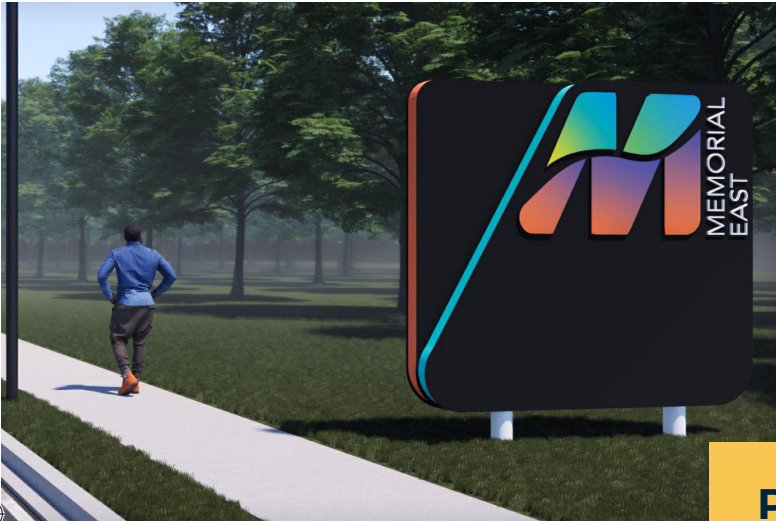

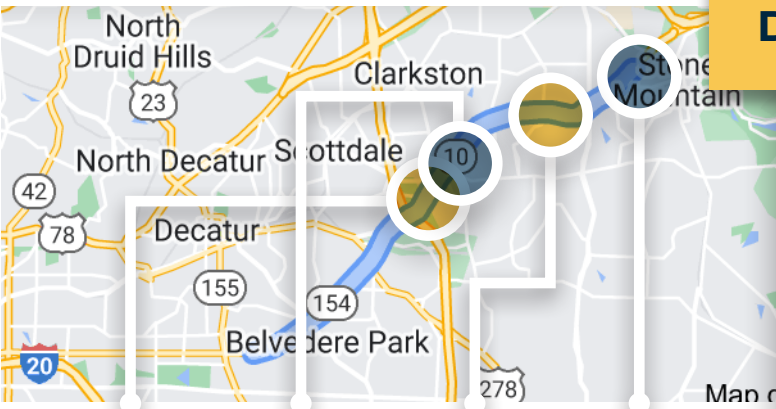
Concept illustrations for gateway features and pocket parks for Memorial Drive

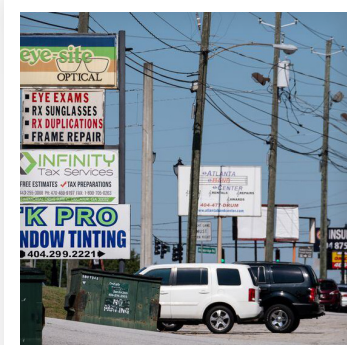
\$50,000 ALLOCATED IN GRANTS TO COMMUNITY ACTION GROUPS (CAGS) FOR MEMORIAL DRIVE REVITALIZATION

The Memorial Drive Revitalization Corridor Plan was completed in Winter 2019 and adopted by the Board of Commissioners in Fall 2020. While some of the plan’s initiative work is being spearheaded by the County, others are community led through the Community Action Groups. These groups are volunteer-led efforts to implement initiatives within the Plan. Five CAGs are working on 11 initiatives in the Memorial Drive Revitalization plan.

MEMORIAL DRIVE COMMUNITY IMPROVEMENT DISTRICT

A Community Improvement District (CID) provide a means to address needs for governmental services and facilities that may be necessary in high-growth, high-intensity, nonresidential areas. In collaboration with the DeKalb Chamber of Commerce, we’re embarking on the administrative setup of a CID for the Memorial Drive corridor. District 4 submitted the proposal in the fall of 2023, and our target launch is May 2025. Throughout this process we have engaged with property owners along the corridor, successfully garnering support for the CID. Groundwork leading to this point was accomplished in 2022, demonstrating the culmination of concerted efforts to advance this community-enhancing endeavor.

DEVELOPING AFFORDABLE HOUSING, EXPANDED TRANSIT, AND RECREATION ALONG MEMORIAL DRIVE

Since the inception of the revitalization of Memorial Drive, I have regarded the area around the Kensington MARTA station as a catalyst to unlocking the full potential of the corridor.

On June 9, 2021, I attended a groundbreaking ceremony for Phoenix Station, 244 units of quality affordable housing across from the Kensington MARTA Station. Quality affordable housing is a critical need in DeKalb County and this development is a step toward fulfilling that need while enhancing the area.

The DeKalb County Housing Authority began construction on the Kensington Point project in early 2022. The development includes a 130-unit senior living property, a 120-unit family property, and 30,000 square feet of office space including the DeKalb Housing Authority headquarters.

Kensington MARTA Station is a site for Soccer in the Streets, a free program with a mission to empower youth through soccer, character development, mentoring, and employability programs throughout Greater Atlanta.

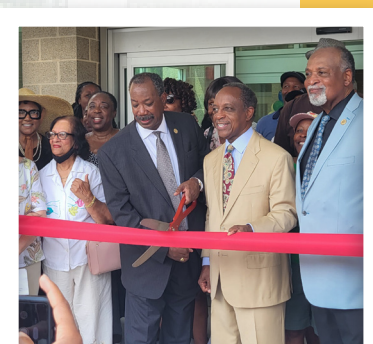
PARKS, RECREATION, & CULTURAL AFFAIRS

EAST CENTRAL DEKALB COMMUNITY AND SENIOR CENTER RIBBON CUTTING

Commissioner Steve Bradshaw hosted an opening ceremony for the East Central DeKalb Community and Senior Center at 4885 Elam Road, Stone Mountain, 30083, on Thursday, July 20, at 11 a.m. Youth, adults, and seniors attended the opening and the tours conducted by community center staff.

The county broke ground on the East Central DeKalb Community and Senior Center in April 2021 and completed the construction in July 2023 with an investment of \$9.6 million, according to officials.

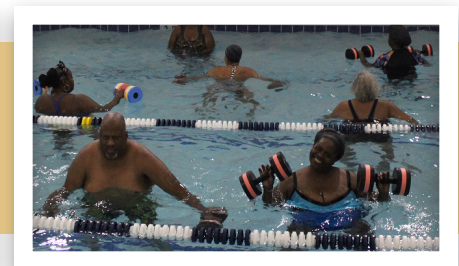
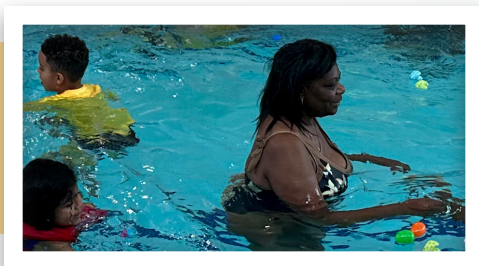
East Central DeKalb Community and Senior Center is unique in that the facility meets the needs of constituents of all ages and features enriching programming across generations.

This energy-efficient 24,000-square-foot center is a modern and functional facility, boasting a 25-yard indoor heated saltwater lap pool and a large exterior patio with furniture. Additionally, there is a large multipurpose dining room with a moveable partition wall and stage, a large commercial kitchen, lounge areas, a library/reading room, a fitness room, an aerobics/dance room, two large classrooms with a moveable partition wall, arts and crafts room, a billiards/game room, administrative offices, restrooms, locker rooms for men and women, security cameras, and Wi-Fi.

DeKalb County Community Development secured Wood Engineering as the architect of record and Headley Construction to conduct the construction initiated in the summer of 2021.

TOBIE GRANT RECREATION CENTER RIBBON CUTTING



Commissioner Steve Bradshaw participated in a joyous ribbon cutting after allocating \$250,000 in park bond funds for the new Tobie Grant Recreational Center on Friday, Sept. 2, at 10 a.m. at 593 Parkdale Drive and Tobie Grant Lane in Scottdale.

The center is named after Mrs. Tobie Kendall Grant (1887-1968), an African-American community leader, advisor, businesswoman, and philanthropist. The center opened in 1962 after Mrs. Grant donated 40 acres to the Scottdale community for a community recreation center and library.

Today, the \$9.3 million, 29,835-square-foot recreation center offers intergenerational programming and includes a library, multipurpose rooms, administrative offices, a multipurpose court, gymnasium, and track.

ENVISIONING A BETTER CEDAR PARK

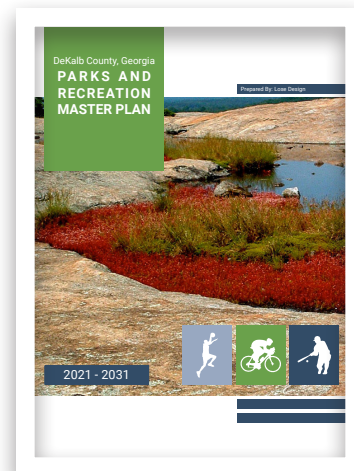

BIG BROTHERS BIG SISTERS: 50 MEN TO MENTORS

The Big Brothers Big Sisters 50 Men to Mentors campaign was officially kicked off in partnership with Commissioner Bradshaw in January of 2023 at District 4's first Quarterly in the Fourth Community Breakfast meeting of the year.

THE CHALLENGE: In DeKalb there were not enough Men (Bigs) signing up to serve as mentors to boys (Littles). We needed to help fill the gap and find at least 50 Men!

THE SOLUTION: Big Brothers and Big Sisters partnered with Commissioner Bradshaw to get the word out and encourage participation. To further facilitate this effort, the application and qualification process were expedited, cutting approval time down from one year to 3 months.

In addition to assisting in the marketing and recruiting efforts of Big Brothers Big Sisters of Metro Atlanta, Commissioner Steve Bradshaw's office allocated \$75,000, and then another \$50,000 to support the organization's ongoing mission.

COMMISSIONER BRADSHAW ANNOUNCES THE KICKOFF OF R.I.S.E. UP PROGRAM 2023 SUMMER COHORT OF YOUNG BOYS OF COLOR

Since October 2019, Commissioner Bradshaw's office has allocated \$95,000 to R.I.S.E. UP, a Young Men's Leadership Development Program serving boys and young men of color residing in District 4.

100 youth have graduated from the program, which employs S.T.E.M. to foster leadership and positive identity development for young boys.

R.I.S.E. UP added a high school cohort of fifteen mentees this programming year, and Dr. Kinnis Gosha, the lead facilitator since 2019, incorporated 13 Morehouse College student mentor positions into the eight week program.

R.I.S.E. UP is an amazing program to persuade, guide, and push our young boys to be the best they can to be successful in this world.

We often think of our boys' success as something internal to some individuals - their innate drive, grit, or brilliance. However, this program shows that the connection between the students and other successful college men is vital. Confidence and motivation to persist come from high-quality peer relationships within an academic environment, especially with mentors who share a common identity. I'm so appreciative of this R.I.S.E. UP program.

The 4.3-acre site south of the rail station will feature 259 units of affordable senior and workforce family housing, HADC's new headquarters, community space and amenities, and convenient access to MARTA bus and rail service

This Kensington Pointe Senior Living Apartment development is a 100-percent affordable, 74-unit community, reserved for residents 55 and older with incomes between 30 percent and 60 percent of the Area Median Income (AMI).

SENIOR CENTER MONTH PROCLAMATION DAY

Presented by District 4 Commissioner Steve Bradshaw, the proclamation acknowledging DeKalb County Senior Centers and the services programs and resources available to DeKalb County Seniors, was entered into the official record of DeKalb County, GA on September 12, 2023.

A Proclamation

Whereas, September is nationally recognized as a time to honor the energy and vitality that today's seniors bring to senior centers throughout the United States. The 2023 Senior Center Month theme is "Discover Yours . . .", which focuses on the many ways that senior centers promote positive images of aging, provide vital community connections for older adults, and demonstrates what the future of aging can be for all of us; and

Whereas, the *South DeKalb Senior/Community Center* was opened in 1979 with a new center in 2015 and is the oldest senior center in DeKalb County. South DeKalb currently serves 201 seniors who average 8,220 visits to the center annually. This senior center features an indoor walking track and an active walking club as well as an active drama club; and

Whereas, the *DeKalb Atlanta Senior Center* was built in 1981 and provides a variety of engaging programs that serve seniors living in the Kirkwood community. DeKalb Atlanta has a current membership of 80 seniors who average 4,940 visits to the center annually. This senior center has a talented and dynamic inspirational dance group that performs throughout the county; and

Whereas, the *East DeKalb Senior Center at Bruce Street (Lithonia)* was opened in 1986 and provides nutritious meals, arts and crafts classes, group trips, and other forms of recreation to seniors living in East DeKalb/Lithonia. Lithonia Senior Center has a current membership of 74 seniors who average 4,420 visits to the center annually. These participants have a desire for lifelong learning, which is demonstrated by an energetic book club which meets monthly to discuss the book, and to socialize within the community; and

Whereas, the *North DeKalb Senior/Community Center* was established in 2016 and has a current membership of 65 seniors who average 4,160 visits to the center annually. North DeKalb participants have a passion for fine arts and the theater, and regularly participate in group trips to local plays and other performances. This senior center has a modern architectural design and features a spacious exercise room, computer room, and game room; and

Whereas, the *East Central DeKalb Community & Senior Center* newly established facility July 2023. This 24,000 sq. ft. facility with 30'x75' saltwater lap pool includes a multipurpose hall, classrooms, kitchen, fitness, aerobics/dance, game room, and locker rooms to serve seniors in a state-of-the-art facility.

Whereas, the *Lou Walker Senior Center* is a multi-purpose facility built in 2005 serving over 3,500 senior citizens annually. This 40,000 sq. ft. facility offers a therapeutic pool, computer lab, 59 lifelong learning classes, 53 fitness classes, and 18 technology classes. In 2021, the center was awarded the honor of the first nationally accredited "Senior Center of Excellence" in DeKalb County by the National Council on Aging; and

Whereas, the *Central DeKalb Senior Center* built in 2015 has a current annual membership of 873 seniors



HEALTH & HUMAN SERVICES

Health and Human Services (HHS) are critical components of a community's well-being, playing a vital role in enhancing the quality of life for residents. DeKalb County, Georgia, is no exception, and the importance of HHS extends to public health, social services and welfare, community well-being, economic impact, educational outcomes, emergency response and preparedness, and community engagement. By addressing a wide range of physical, mental, and social needs, these services contribute to building a strong, vibrant, and resilient community.

COMMISSIONER BRADSHAW SERVED AS VICE CHAIR OF THE DEKALB COUNTY BOARD OF HEALTH

As the COVID-19 pandemic further revealed the insecurity of many citizens and local nonprofit agencies, DeKalb County CEO Michael Thurmond appointed Commissioner Bradshaw to serve on the DeKalb Board of Health as vice chair from 2021 through September 2023.

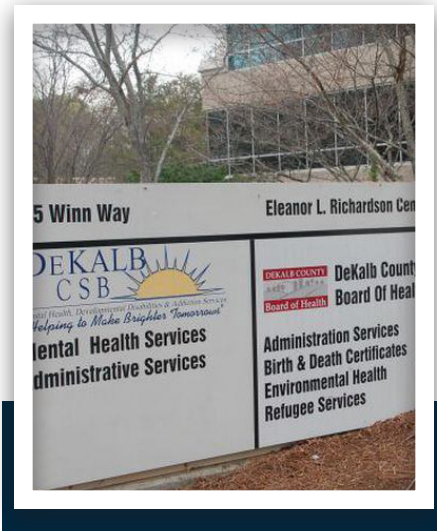

DeKalb CSB is accredited by the Commission on Accreditation of Rehabilitation Facilities (CARF).

Steve Bradshaw allocated \$50,000 of 2020 CARES ACT and another \$50,000 of 2021 American Rescue Plan funding to Wade Walker YMCA to support individuals and families impacted by the COVID-19 pandemic. The ribbon cutting took place in September of 2022.

Wade Walker YMCA provided more than 22,836 meals and 18,895 grocery boxes to DeKalb County residents in 2020 and 2021. INFRASTRUCTURE / SPLOST

Infrastructure is the backbone of DeKalb County, supporting economic development, education, public health, safety, and overall community well-being. A well-maintained and forward-thinking infrastructure system contributes to the county's resilience, attractiveness to businesses, and the overall satisfaction of its residents.

A Special-purpose local-option sales tax (SPLOST) is an important mechanism for funding county improvements because it provides a dedicated source of revenue for specific projects that benefit the local community. SPLOST is typically a temporary sales tax that is levied for a specified period, and the funds generated are earmarked for specific capital projects and infrastructure improvements.

YOUR PENNIES AT WORK: RESIDENTIAL TRAFFIC CALMING

Commissioner Steve Bradshaw is committed to the safety of constituents living, working, and playing in DeKalb county. The District 4 Office is engaged in traffic calming interventions to keep constituents, pedestrians, and motorists out of harm's way.

DeKalb County developed a Traffic Calming Program to address the concerns of the citizens regarding the speed of traffic on residential streets. For a street to be eligible for the traffic calming program, it must be classified as local residential on the DeKalb County Functional Classification Map and have a posted speed limit of 30 mph or less. 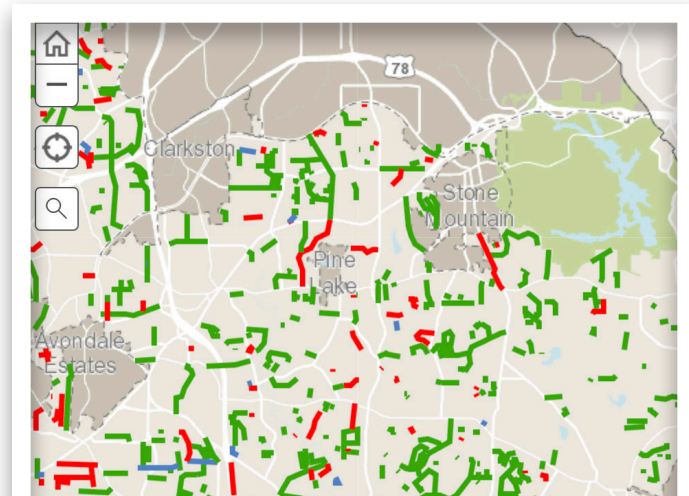


The first community meeting in May heard several concerns from residents and drivers. Top traffic concerns were congestion in the corridor, speeding, and safety. Our goal is to improve major intersections from an operations standpoint, reduce crashes, and increase pedestrian safety.

SPLOST: SPECIAL-PURPOSE LOCAL-OPTION SALES TAX

DeKalb County SPLOST supports county-wide improvements promoting added value to DeKalb County and improved quality of life for all residents and all stakeholders.

Voters adopted the current SPLOST in a referendum in November 2017, and runs from 2018 until 2024. During these six years, SPLOST expects to generate \$636 million for capital improvements for the county and city governments in DeKalb County. This one-cent sales tax provides funding exclusively for capital projects – roads, buildings, vehicles, major equipment, and other long-lived improvements. Because of the success of the current SPLOST, I support continuing to hear about constituent ideas and priorities for capital improvements and quality-of-life enhancements in DeKalb County.

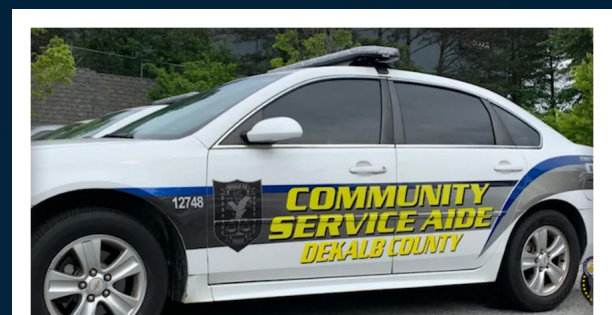
PUBLIC SAFETY: FRONT LINE

Public safety is a collaborative effort involving government, nonprofits, and community organizations. While police and fire departments play vital roles, various other areas and agencies contribute, such as animal control, building enforcement, child protective services, cybersecurity, rehabilitation, emergency medical services, mental health services, public education, public health departments, utilities, transportation, and infrastructure safety.

STARTING SALARY BOOST IN FY2023 BUDGET SOLIDIFIES DEKALB POLICE AND FIRE AS AMONG THE HIGHEST PAID IN THE SOUTHEAST

The DeKalb County FY2023 budget, which includes \$4.3 million to raise the starting salaries for police and fire recruits and provide increases for veteran public safety personnel, was passed by the DeKalb County Board of Commissioners. This salary boost maintains DeKalb's status as one of the highest-paid police and fire recruits among large local governments in the Southeast and the state, respectively.

As of April 1, 2023, the starting salary for new police recruits is \$55,000, an 8.9% increase over the previous \$50,500 – and is 19% above the regional market average of \$46,352. The starting firefighter salary is \$51,000, a 9.7% increase over the previous \$46,500 – approximately 9.1% above the local market average of \$46,728 for Atlanta, South Fulton, Cobb, and Gwinnett counties.



DeKalb County Community Service Aides respond to low-level calls like theft, traffic hazards, burglaries, car break-ins, vandalism, harassment, animal complaints, and directing traffic. Chief Ramos said the department receives about 30,000 calls a month, with more than 2,300 considered low-level calls.

It is safe to say we use Flock daily in almost every case, whether it's a missing person, stolen vehicle, assault, hit and run, etc. FLOCK has been a precious investigative tool for our department.

Detectives can utilize the FLOCK cameras in investigations to leverage technology and allow for cameras to capture vehicle images in the area of a reported crime / overdue motorist / missing person case and for investigative follow-up or immediate dissemination.

We recently had a rash of auto theft subjects striking across Metro Atlanta. By utilizing FLOCK, we were able to track and arrest 22 suspects. In addition, please see a recent local media story about a homicide arrest made possible by FLOCK. Visit bit.ly/FLOCKtagArrest

Today, the use of FLOCK is considered a best practice in improving public safety throughout district 4 and DeKalb county.

On December 5, 2023, Police Chief Ramos reported that DeKalb County has a total of 371 FLOCK cameras in place and expects to install an additional 60+ throughout high-priority areas of DeKalb in 2024.

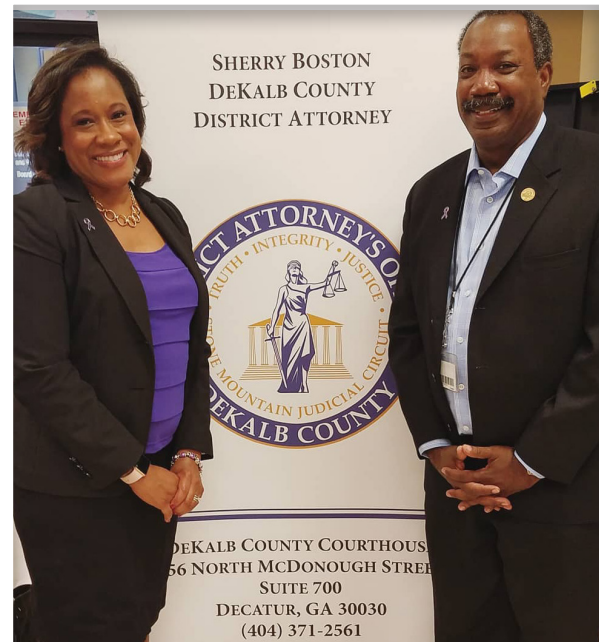

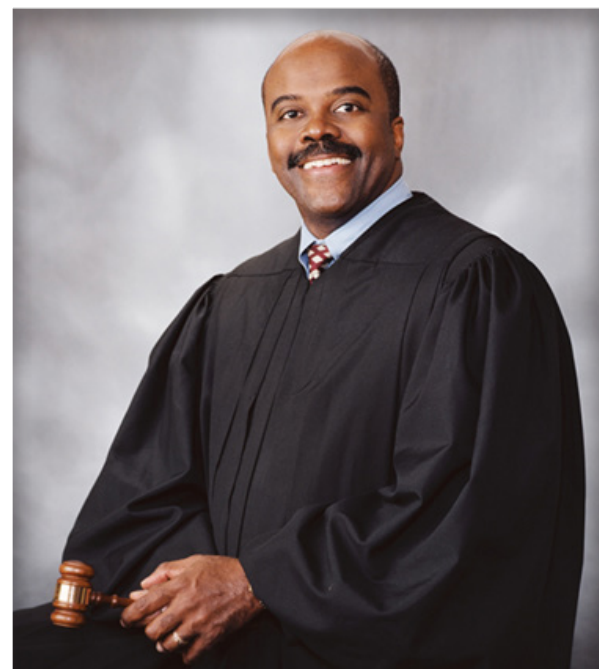
COMMISSIONER BRADSHAW & DEKALB COUNTY DISTRICT ATTORNEY SHERRY BOSTON'S DIVERSION PROGRAMS

Stopping Trends of Repeat Incarceration with Diversion and Education (STRIDE), is a voluntary diversion program that holds young adults accountable for serious non-violent crimes they have committed, while also ensuring their civic and career opportunities remain intact. STRIDE partners include RED, Inc., WorkSource DeKalb, American Alternative Court Services and Acivilate.

Commissioner Steve Bradshaw has also allocated \$50,000 to the Women's Resource Center to End Domestic Violence, an organization that provides emergency/crisis intervention services for women, children, and others who have been displaced by domestic violence. Funding helps to operate, in part, the 24-hour crisis hotline that provides safety planning, useful information, and resource referrals for those in need of community support.

BRADSHAW ALLOCATED \$110,000 OF DISTRICT 4 RESERVE FUNDS TO ACCOUNTABILITY COURT PROGRAMS TO DATE

The DUI Court program, started by Judge Alvin T. Wong and Judge Tony DelCampo in 2004, addresses substance abuse and addiction issues while teaching participants to take responsibility for their actions. The mission of the DUI Court Program is to enhance public safety by reducing recidivism of DUI offenders by breaking the cycle of addiction through a combination of individualized treatment, personal accountability, and intensive court supervision. The Council for Accountability Court Judges named the DUI Court Program a model court from 2020 to 2023. As of Thursday, Jan. 19, 1,053 participants have graduated from the program.

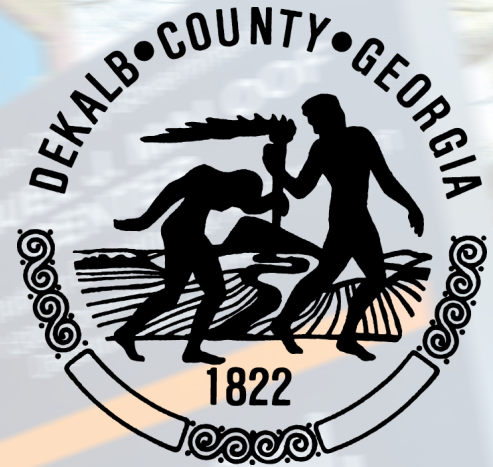
